**NOTIFICATION**

*Islamabad, the 19<sup>th</sup> January, 1998*

**S.R.O. 71 (1)/98.-** In exercise of the powers conferred by Section 29 of the Seed Act, 1976 (XXIX of 1976), read with Section 10 thereof, the Federal Government is pleased to direct that the following amendments in the Seeds (Truth-in-Labeling Rules, 1991) namely:-

In the aforesaid rules:-

- (1) In rule 8, after sub-rule (5), the following new sub-rules shall be added, namely:-
  - (6) The importer may authorize his agent for clearance of seed consignment in accordance with Schedule VI.
  - (7) The authorized agent shall give an undertaking not to sell seed found below seed standards as specified in Schedule VII.
  - (8) The Seed Inspector shall inform the custom authorities to release seed consignment in manner specified in Schedule VIII.
  - (9) The Seed Inspector shall submit the seed sample to the Seed Analyst for analysis as specified in Schedule IX.
  - (10) The Seed Analyst shall convey the analysis of the sealed samples to the Seed Inspector in the manner specified in Schedule X.
  - (11) The Seed Inspector shall inform the importer not to sell seed found below standard as given in Schedule XI and also inform the custom authorities about rejection of seed consignment as given in Schedule-XII, and
- (2) After Schedule V, the following new Schedules shall be added namely:-
