SUBJECT: MEETING OF THE COORDINATION COMMITTEE TO PROPOSE A NATIONAL AGRICULTURE INNOVATION AND GROWTH ACTION PLAN

The second meeting of the Coordination Committee was held on 30th April 2025 in B-block Committee room, Ministry of National Food Security and Research. This meeting served as a continuation of the discussion on the draft recommendations by working groups. The Minister for National Food Security and Research chaired the meeting. The list of participants is annexed.

2. Minister, NFSR welcomed all participants and briefly explained the decisions of 1st meeting on the subject matter. He stated that the purpose of this meeting is to discuss the recommendations from working groups who had completed 80% of their respective work by last meeting held on Friday, the 25th April, 2025. It was decided in the last meeting to convene a second meeting to review the recommendations made by working groups and then finalize them to present to the Prime Minister.

Minister MNFSR asked Mr. Hannan Ikram - Consultant at Tabadlab to present the recommendations and workplan designed by the working groups. Mr. Hannan briefly explained the recommendations of the two working groups along with timelines, responsible entities, and resources for each recommendation. Minister of State Bilal Azhar Kiyani suggested that roadmap developed by Ministry and recommendations from working groups should be synchronized and one final document should be presented to Prime Minister. Minister for NFSR agreed and asked conveners of working groups to come up with one master document with non-overlapping recommendations. Mr. Hannan, on behalf of all working groups asked for some time to complete this exercise but Minister for NFSR and Minister EAD both asked to complete the tasks in time mentioned in notifications.

The Chair concluded with the instructions to arrange another round of meeting tomorrow i.e. 1st, May 2025.
