OFFICE ORDER

SUBJECT: CONSTITUTION OF APPELLATE COMMITTEE FOR REDRESSAL OF GRIEVANCES REGARDING REJECTED MANGO TREATMENT PLANTS BY THE TECHNICAL AUDIT COMMITTEE DEPARTMENT OF PLANT PROTECTION

In order to ensure compliance with phytosanitary requirements and to facilitate the smooth export of mangoes for the 2026 season, the Department of Plant Protection (DPP) has notified and approved various treatment plants. These plants have commenced treatment operations under the supervision, of Pre-Shipment Inspection (PSI) agencies and DPP officers. The Competent Authority, i.e., Additional Secretary-I, Ministry of National Food Security & Research (MNFSR), has been pleased to constitute an Appellate Committee as per the following composition:

- ii. Mr. Nazar Iqbal, Director (Registration), FSC&RD (**Member**)
- iii. Mr. M. Samiullah Channa, Director, DPP (**Member/Secretary**)


Terms of Reference (ToRs):

- i. To review and redress grievances of exporters and treatment plant owners regarding issues/rejections/observations of the Technical Audit Committee.
- ii. To conduct surprise visits of mango treatment plants and check posts as deemed necessary.
- iii. To supervise the overall mango export treatment process during the season and identify any gaps regarding pest management, risk analysis etc.
- iv. To submit a weekly progress report to the Secretary, M/o NFS&R.
- v. To undertake any additional assignments as directed by the Competent Authority.

Timelines:

- i. The Committee shall submit its initial redressal report within three (03) days of receipt of grievances to the Competent Authority.
- ii. A final decision on the report shall be taken within forty-eight (48) hours of its submission.

2. The committees will work under overall supervision of Additional Secretary-I.
3. This issue with the approval of Additional Secretary-I, M/o NFS&R.
